Course Description: Analysis of interference experiments with waves and particles; fundamental concepts of quantum mechanics, Schrödinger equation; angular momentum, atomic beams; hydrogen atom; atomic and molecular spectroscopy; Pauli principle; simple applications in the physics of elementary particles.

Prerequisites: PHYS 2604, MATH 2000 [1.0] (may be taken concurrently), or MATH 2004 or MATH 2008, and MATH 3705 (may be taken concurrently), or permission of the Department.

Textbook (recommended but not required): *Introduction to Quantum Mechanics*, third edition, by David J. Griffiths and Darrell F. Schroeter, Cambridge University Press 2018.

Topics to be Covered:

- ▶ Motivations: experimental evidence, Planck's law, particle-wave duality for photon and electron, de Broglie matter wave, the classical limit.
- ▶ The Schrödinger equation and wavefunction, statistical interpretation, average of

operators, Ehrenfest's theorem, stationary state.

- ▶ Solving a bunch of Schrödinger equation problems in one space dimension, application of the Heisenberg uncertainty principle.
- ▶ * Formalism. Linear operators, Dirac's bra and ket, Hermitian operators and observables, the matrix representation, common eigenstates, conservation laws.
- ▶ Schrödinger equation in three space dimensions, orbital angular momentum, spherical harmonics, hydrogen atom, radial wavefunctions, energy levels, atomic transition selection rules, Paschen-Back effect.
- ▶ Spin angular momentum, Stern-Gerlach experiment, Pauli exclusion principle, spin statistics, total angular momentum, Clebsch-Gordan coefficients, Zeeman effect.

Grading Scheme:

Homework Assignments (40%):

There will be 5 sets of homework problems throughout the semester. They will be announced and posted via Brightspace. Submit your work using Brightspace (typically two weeks after the release date). You are encouraged to study together, and write separately. **The work you hand in must be your own.** Late assignments will not be accepted, unless permission is received from the professor for documented reasons.

Mid-term Exam (20%):

The midterm exam will be held during class hour at a date to be determined. It will be 80 minutes long, closed-book, closed-note exam. A formula sheet will be provided.

Final Exam (40%):

The final exam will be held during the final exam period. It will be 3 hours long, closed-book, closed-note exam. A formula sheet will be provided.

For the exams it is forbidden to: use unauthorized aids, look up any information online (outside of Brightspace), consult with any other person, or share exam content with anyone.

If you missed an exam, you must notify the professor within three working days after the date of the exam. Deferred exams will be permitted for documented reasons (illness, injury or other extraordinary circumstances beyond the student's control). Sanctions for not abiding by Carleton's Academic Integrity Policy

A student who has not adhered to Carleton's Academic Integrity Policy may be subject to one of several sanctions:

1. If you take full responsibility for your actions, and it is the first time you have violated the policy, you will receive zero on the assessment. If you are found to have violated the policy but do not take responsibility, an additional grade deduction will be applied (e.g. an A- will become a B+)
2. Subsequent violations of the policy may result in more severe sanctions such as failing the course, suspension from all studies and/or expulsion.

Process of an Academic Misconduct Investigation

Step 1: The instructor believes misconduct has occurred and submits documentation to the Dean of the Faculty of Science.

Step 2: The Dean reviews documentation and can proceed with or dismiss the allegation.

Step 3: If sufficient evidence, the student receives an allegation statement by email. Ombuds services is copied on the email.

Step 4: The student provides a written response to the evidence provided.

Step 5: Either party may request a meeting between student, dean, and the ombudsperson.

Step 6: Dean informs the student of the decision.

Appeal: Student has the right to appeal the decision.

Plagiarism

What are the Penalties for Plagiarism? A student found to have plagiarized an assignment may be subject to one of several penalties including: expulsion; suspension from all studies at Carleton; suspension from fulltime studies; and/or a reprimand; a refusal of permission to continue or to register in a specific degree program; academic probation; award of an FNS, Fail, or an ABS.

What are the Procedures?

3. All allegations of plagiarism are reported to the Dean of Faculty of Science. Documentation is prepared by instructors and/or departmental chairs.
4. The Dean writes to the student and the University Ombudsperson about the alleged plagiarism.
5. The Dean reviews the allegation. If it is not resolved at this level then it is referred to a tribunal appointed by the Senate.
